## Authorization and Agreement

By signing this Membership Application for Quail Village Golf Club, I hereby authorize Quail Village Golf Club, through its representatives, to make inquiry of my financial condition, our family and professional background and specifically authorize them to make inquiry of consumer credit reporting organizations.

The undersigned does hereby acknowledge, accept and understand that I have truthfully and to the best of my ability answered all application questions. If my Membership Application is granted, I agree to observe and be bound by the Membership Plan and Rules and Regulations of Quail Village Golf Club in the present form or as may be amended, beginning with the effective date of membership referenced below, until September 30, 2022. I understand that this agreement shall automatically renew at the end of the current term for a successive 36 month period, unless either party gives written notice of its intention not to renew at least 30 days prior to the expiration and that all subsequent membership renewals will be subject to the prevailing dues and fee schedules at time of renewal. I understand that if I decide to cease being a member at any time prior to September 30, 2022, my eligibility for the discounted rate will be deemed void and I will be responsible upon leaving to immediately paying the Club the difference between the 25% discounted rate I paid and the regular annual dues for all years I was a non-resident member before my departure. Exceptions will be made for those relocating more than 50 miles from the club.

Non-Resident Equity Resignation Policy: Non-Resident Equity Golf Club Member(s) resigning from the club must do so in writing and shall be subject to six-months annual dues. Unused trail fees or prepaid cart fees shall be pro-rated and refunded after the six-month period has passed. In case of death (a) membership will be terminated if individual membership, (b) membership will be adjusted from family to individual.

I acknowledge that I have received a copy of the Articles of Incorporation, By Laws, and Covenants for Quail Creek Village and agree to abide by these documents. I understand that when I decide to resign my membership that I must submit the original certificate with a letter of resignation to Quail Creek Village Foundation Incorporated and they will act as the transfer agent in the re-sale of my membership.

The Foundation shall not be obligated to transfer any Non-Resident Equity Golf membership until a successor Non-Resident Equity Golf Member(s) has been admitted and has paid the membership upgrade fee in full. Until such time as the Foundation has resold the Non-Resident Equity Golf Membership Certificate, the Non-Resident Equity Golf Member/s shall be subject to Six (6) months of annual dues from the date said membership and certificate is surrendered but not subsequently assessed annual or special assessments as outlined in section 4.2.2 (c) of the Covenants for Quail Creek Village. The Foundation shall pay to the retiring or terminating Non-Resident Equity Golf Club Member an amount equal to that being currently charged for the certificate, less a transfer fee of up to fifty percent-50% of the sales price. The Board of Directors has the authority to terminate a Golf Club Membership for a Non-Resident Equity Golf Members whose assessments are in arrears in an amount greater than the value of the certificate.

I acknowledge, accept and understand that I am personally liable and responsible for all financial obligations relating to my membership and any of my family members who will be utilizing Quail Village Golf Club. I further agree that I will pay an unpaid balance of any fees, dues or charges for which I or my family may be responsible. These fees or dues may include but are not limited to monthly dues, finance charges, late fees, and food minimums. In the event that any charges, fees, and/or dues to my account are past due, my account will be deemed to be delinquent. An account is deemed delinquent when the balance has been past due for more than thirty (30) days after the date of the statement. In the event my account becomes delinquent, I authorize the Club to charge my credit card for all fees, dues and charges greater than sixty (60) days past due. Should my account be referred to an attorney for collection, then I agree to be responsible for all costs of collection, including an attorney's fee of 33 1/3% of the balance then due and owing at the time of referral.

I further declare that the above information which I have supplied on this application is true and correct, and acknowledge that any misrepresentation thereof will be grounds for rejection of my application or dismissal from membership in the club.
